Resolution authorizing the issuance of the District's General Obligation Bonds, Series A of 2009, in the approximate amount of \$14,445,000, the proceeds of which are to be used for the current refunding of the District's outstanding General Obligation Bonds, Series of 2001A, General Obligation Bonds, Series of 2002, General Obligation Bonds, Series of 2003A and General Obligation Bonds, Series of 2004.

Resolution authorizing the issuance of the District's General Obligation Bonds, Series AA of 2009, in the approximate amount of \$8,250,000, the proceeds of which are to be used for the current refunding of the District's outstanding General Obligation Bonds, Series of 2003.

Approval of these two resolutions will save the district considerable amounts of money in debt service.

Mr. Miller noted that approving the resolutions will save the district approximately \$675,000.
