2.1 Student Representatives Update on Activities and Events at Souderton Area High School

Senior Brigitte Magee reported on several events and high school activities that occurred during the month of March including the recent Science Fair, where several students advanced to the state competition. The Pennsylvania Academic Decathlon was held at the high school and attended by schools throughout the state. Brigitte also commented on winter athletics and the start of the spring sports season. She also noted that several student field trips have been taken including a design class trip to Ikea and a field trip to Universal Technical Institute to explore post high school opportunities in the trades.
