## 1. Welcome

Dr. Hey summarized 16 comments that had been received in support of in-person learning. Comments also included thanks to administration and the Board for re-opening plan, requests for the Board to vote to re-open as planned, and a comment that virtual learning poses a hardship for one family. In addition, a comment was received noting insufficient notification of the hybrid learning model and the delay start of school.

Dr. Hey also read the following statement from Carol Luciani, President of the Souderton Area Education Association:

This has certainly been a summer like no other. We understand the decisions that went into developing a reopening plan for the 2020-2021 school year have not been taken lightly and weighed heavily on those involved in the process. We are in a troublesome situation with the unprecedented impact of a pandemic. I am proud to represent the dedicated and hard-working teachers of the Souderton Area Education Association. We are looking forward to doing the job that we love. Whether it be in our physical schools or virtually on the Souderton Area Online Academy, our teachers will give their all to give our students the best education possible. We want to be back in our classrooms with our students. We need to do that safely, and we need to follow the rules: wearing face

coverings; physical distancing of 6 ft. in schools and classrooms; using the scientifically based guidelines issued on August 10th to determine when it's safe to hold in-person instruction and when online only or a blended approach of in-person and online instruction is needed.

Everyone wants to get "back to normal." But that isn't something we can rush at the expense of the health and safety of our students, faculty and staff, and families. If we want to get back to normal, everyone has to follow the rules. I appreciate that it isn't easy to change course and move to a hybrid approach to start the school year. The ever-changing recommendations from PDE and DOH were challenging. We have to trust the fact that the medical experts know more than we do. Not doing so would be reckless.

PDE states they only recommend full in-person learning in the event that a county has below 5% positivity AND an incidence rate below 10. Last week Montgomery County had an 7-day incidence rate of 35.86, 3.5 times the recommendation to even consider full in-person learning. All of this data must be considered before you decide to fully re-open our buildings.

The members of Souderton Area Education Association will continue to do the job we love, despite the obstacles in our way. But we ask you to do your job, too. Look at ALL the scientific data and recommendations given. Keep everyone safe.

# 5. Discussion/Action Agenda

Dr. Hey shared his screen to review the School Reopening Plan. He reviewed the major considerations which included:

- Delay the first day of school, revise school calendar
  Provide blended/hybrid option
- SAOA and associated staffingGuidance from PA Departments of Education and Health

District-wide enrollment data was reviewed; reflecting that 74% of student population would be receiving in-person instruction and 26% would be learning virtually with SAOA. Dr. Gallagher reviewed the Hybrid Ramp-Up Plan which explained the orientation week and the cohort attendance model. All students receiving in-person instruction are scheduled to be in class on Tuesday, September 29th. The First Weeks' Schedule was detailed by Mrs. Zweiback for both regular and special education students.

Specifics were outlined for the SAOA students, including device distribution, synchronous and asynchronous instruction, teaming for middle school students, and first week expectations and orientation. Updates were also given on the Home Access Center, busing, device distribution and the athletic program. Mrs. Zweiback previewed a COVID-19 Early Warning Monitoring Dashboard slide and discussed district protocols including cleaning and sanitizing, social distancing, monitoring of student and staff, mask requirements and communication. Mrs. Zweiback noted the Athletic Health & Safety Plan noting the inclusion of PIAA Return to Competition guidelines. Mrs. Zweiback also noted that initially there would not be spectators at athletic events, and this decision would be reviewed weekly.

Dr. Gallagher thanked the Board and the Administration for their work and preparation on the Reopening Plan. He expressed pride in all employee groups for their dedication and commitment to return all students to a safe and equitable learning environment. Dr. Gallagher also thanked the community for their support and asked for patience and understanding as the organization moves forward with its plan.

Mr. Keith thanked the Administration for their work on the Reopening Plan, noting the volume of information in its contents. He encouraged the community to continue to check the school district website and to continue to reach out with questions and concerns. Mr. Keith asked for questions and comments from the Board and upon receiving none, held motion for the following items.

## 9. Public Comments

9.1 Public Comments

Dr. Hey noted that one public comment on non agenda items, had been received from Veronica Moeller. Dr. Hey read the comment:

I have approached this board in June after the senseless killings of Ahmaud Arbery, Breonna Taylor and George Floyd to start the discussion about race and equity in SASD. Due to the ongoing pandemic and the enormous tasks of trying to open the schools I was told to wait until August, which I found very offensive by the way. In light of another senseless shooting of a black man in Wisconsin, and major sports leagues protesting their games, I am once again asking SASD to engage in conversation about race and equity within this district. I would like an update on the work the equity committee has completed, the community members that are actively participating on the committee and the district's stance on implementing an anti-racist curriculum. Also, I've been "sitting tight" for that equity FAQ tab on the district site. It is now August 27, and it is still not up, shame on you for the lack of urgency on what your community has begged you for. I'd like to leave you with one final thought, a quote from Dr. Martin Luther King.

"The ultimate measure of a man is not where he stands in moments of comfort and convenience, but where he stands at times of challenge and controversy"

I look forward to hearing your response.

Dr. Gallagher responded by stating that equity is the reason that the school district has chosen to reopen its schools; giving each child an equal chance to be educated. He also commented that all district resources have been focused on safely reopening schools during the COVID pandemic. He noted that a follow up of the district Equity Committee would be given at the next Board meeting.

Mr. Keith read from a prepared statement reiterating the Board's commitment to reopening its schools and giving parents a choice of a learning environment. He acknowledged that while some may be disappointed about the initial hybrid approach, the goal for in-person instruction remains firm. Mr. Keith commented that the Board spent many hours exploring and preparing its safety protocols in order to preserve education for the whole child. Mr. Keith cautioned the community against politicizing the virus and reinforced the Board of School Directors goal to provide a safe and affordable education for its students.

Board Vice President Mrs. Scheuren also read from a prepared statement thanking Dr. Gallagher for his comments. Mrs. Scheuren noted that while the current social environment has been challenging to everyone personally and professionally, this Board remained resolute in their desire to put forth options for parents. Mrs. Scheuren reflected on the parent surveys and many comments of support received from the community. She noted that no decision was made lightly and that the School Board oath of office to serve faithfully and with fidelity, had been executed in this process.
