Dr. Gallagher noted the Board's approval of the resolution which opposes Pennsylvania House Bill 2, a voucher program. Dr. Gallagher commented on the struggles that traditional public education faces and the probable loss of funding that the school district would face if the proposed legislation would be approved.

Vice President Mrs. Scheuren suggested that the Board research the positions that our local legislators are taking on this particular issue. Mrs. Scheuren noted that possible ramifications of this bill would allow for percentile tax increases without oversight. Mrs. Scheuren also commented that it remains a challenge to accurately generate a school district budget when neither fair funding nor charter school reform are in place. Both are variables that fall on to the taxpayer.

Mr. Keith encouraged the public, regardless of a personal position, to be informed on the issues that affect the school district.
