A regular public meeting of the Souderton Area Board of School Directors was held Thursday, April 26, 2007 at the District Administrative Office in the Tinner Board Room. The meeting was called to order at 7:30 PM by President Eric MacDougall, followed by the Pledge of Allegiance.

RECOGNITIONS

<u>Souderton Area High School/North Montco Technical Career Center Winners</u> Dr. Amuso introduced Sam Varano, principal of Souderton Area High School, who spoke about the North Montco Technical Career Center winners. Mr. Varano introduced the students and talked about HOSA and how the students competed. The North Montco Technical Career Center - Allied Health students won gold medals at the state level Health Occupations Students of America competition in Lancaster. The Health Education Team prepared a lesson for an elementary school which discussed common disabilities like cerebral palsy, blindness, deafness, and seizures. These students will be going to Orlando, Florida in June to complete in the national HOSA competition.

<u>Report of the Student Representatives to the Board - DAN BITNER – Senior – Class of 2007</u> Dan Bitner reported on recent and future activities at the Souderton Area High School.

Donation to SAVE Organization

Dr. Amuso spoke about a \$1,500 donation that was recently received by the SAVE Organization. The High School SAVE organization received this donation from Emerson Charitable Trust to help fund the completion of the CONNECTIONS environmental building, located at the West Broad Street Elementary School. Dr. Amuso presented this as an information item.

WORKSHOP AGENDA ITEM

Accountability Block Grants

Dr. Amuso presented a sample letter addressing the present status of the Accountability Block Grants. He indicated that if requested by the Board, a letter would be sent to all local legislators to communicate Souderton's disappointment with the Accountability Block Grant distribution program. He spoke about the grants and how Souderton has used the money in the past, and indicated that the district can not take advantage of this new program because the additional fund are specifically earmarked for creation or expansion of a pre-K or full-day Kindergarten. Souderton does not have ten additional classrooms to take advantage of the new program. Legislators will be asked to consider allowing SASD to use funds for other programs.

Mr. Gallagher explained what programs have been put in place in the past with these funds. There is a very successful elementary technology program in its third year. Some programs were expanded last year when the state allocated more funds that were used to provide full-time social worker services for families with children who are at-risk. Another initiative was the K-2 Literacy Coach who works with teachers in improving writing and reading and staff development skills.

Board members discussed the purpose of accountability block grants, the status of present programs, and the need for communication with local legislators about funding.

Dr. Amuso explained that the letter drafted to legislators communicates that Souderton does not have the classroom space needed to expand or create a pre-k or full day kindergarten. If the district went with full day kindergarten, we would need 10 more classrooms. There are other school districts in the same situation.

Mrs. Cole indicated that there was discussion about this topic at the IU. Many of the Montgomery County schools have the same concern. The school districts that already have full-day kindergarten in place cannot take advantage of the Accountability Block Grant.

Mr. Verbeke asked that the district make certain to include the reasons why Souderton can not take advantage of the new Accountability Block Grants in the letter to local legislators.

Dr. Amuso mentioned that the letter will be redrafted and returned to the board for approval.

WORKSHOP AGENDA ITEM (CONTINUED)

Accountability Block Grants (continued)

Mr. Hugh Donnelly, of Franconia Township, questioned the funding shortfall for the high school project and asked that the Board remember the taxpayers when determining tax increases.

Mr. MacDougall clarified that the Board had originally decided to only finance \$90M of the \$114M project.

PUBLIC COMMENT ON AGENDA ITEMS

Dr. Amuso explained that the stadium project was not included in the project bid. The plan was to shift money from the General Fund to the Capital Reserve Fund to have money available for other maintenance projects as needed. The Board did not want to borrow more money than needed.

Mr. Ernest Rosato, of Upper Salford, expressed that the public should be made fully aware of how the Board plans to acquire the funds. He suggested cutting increased spending.

Mr. MacDougall clarified that the \$4.2M surplus came from new housing real estate taxes and other revenue sources. The previous Board planned to use the surplus over the long range plan of the high school project to pay off the high school.

REPORT OF THE PRESIDENT

A Board workshop was held on April 12, 2007 following the Board meeting. The workshop lasted 20 minutes.

An Executive Session was held this evening prior to the Board meeting to discuss personnel items. The meeting lasted approximately 15 minutes.

Mr. MacDougall announced an Executive Session after tonight's meeting to discuss personnel.

Education-Personnel Committee – Mr. Mark Leer, Chairperson

Mrs. Cole presented the Education-Personnel Committee report.

- Secondary Health Curriculum Scope and Sequence Revisions. The changes were reviewed by the committee.
- Revision of 6th Grade Art Planned Course This course revision was reviewed and is on tonight's agenda for a Second Reading.
- The committee reviewed The Governor's Commission on College and Career Success Report.
- Several requests for student field trips were reviewed and appear on tonight's agenda for action.

BOARD COMMITTEE REPORTS (CONTINUED)

<u>Operations Committee</u> – Mr. R. "Bud" Miller, Chairperson No report.

Finance Committee – Dr. Jack Parry, Chairperson

- Mrs. Natali answered questions regarding myLunchMoney.com, an online prepayment service that parents can utilize for their children's Food Service purchases. There is no cost to the district. Parents will be charged \$1.95 for each payment they make.
- After reviewing student software from four companies, the administration is recommending the purchase of a web-based system K-12 student management system, eSchoolPlus, to replace the current SASI system that has been in place for approximately nine years. The initial cost is \$205,460. Mr. Roberts and Mr. Gallagher both discussed the strengths of this particular software program.
- PlanCon K for General Obligation Bonds, Series of 2006, refunded in December 2006, was reviewed. The Board will take action later in tonight's agenda.
- A new PLGIT account was opened for the proceeds from the 2007 Bond Issue. There will be a recommendation to ratify the opening of this account later in the agenda.
- Mrs. Berk reviewed the 2007-2008 Montgomery County Intermediate Unit Special Education agreement for budgeted services that total \$838,817.14. This will be an action item on tonight's agenda.
- The recommendation to transfer \$4.22M from the General Fund to the Capital Reserve Fund was reviewed again by the Finance Committee. This will be an action item on tonight's agenda.
- The committee reviewed a spreadsheet highlighting the costs and related revenues of selected federal, state, and local mandates.

Policy Committee – Mrs. Tracy Cole, Chairperson

Mr. Verbeke presented the Policy Committee report.

- Board Policy 201.1. Admission to Kindergarten/Admission of Beginners. The committee reviewed and offered suggestions for changes and recommended that the policy move to a Third Reading on tonight's agenda. The change in this policy removes the exceptions to the August 31 date for age for admission.
- Proposed Anti-Bullying Policy. The review of this new policy was continued. The committee will continue to review this policy at their next meeting.

ACTION ITEMS/CONSENT AGENDA

Dr. Amuso announced that item IX - H would be moved to the Actions Items/Discussion Items section of the agenda.

Dr. Baumgartner asked for clarification on field trip requests by asking if the Board votes on allowing students to participate or how the trips are financed.

Dr. Amuso explained that as per Board policy, all overnight and out-of-state field trips must go through Board approval.

Recommendation to Transfer \$4.22 Million to Capital Reserve Fund

Dr. Amuso indicated that it was the administration's recommendation to transfer \$4.22 M of the General Fund balance to the Capital Reserve Fund.

There was a motion by Mr. Miller, second by Mr. Currie.

Mr. Currie indicated that transfers should not be handled this way. He expressed that there was not enough information to transfer the money and would vote no.

Dr. Baumgartner spoke about pay now or pay later. He questioned what the tax rate would be if \$4.2M were deducted from the current tax rate and returned to the taxpayers.

Dr. Amuso responded that if the \$4.2 M were used for tax relief this year, the district would not have the necessary funds for next year and would have to raise the tax rate by way of referendum. Dr. Amuso added that the administration would need to look at expenditure reductions for 2008-2009. The district is not permitted to decrease professional staff since we are a growing school district.

Dr. Parry made a motion to table the recommendation and refer back to the Finance Committee for further discussion. Mr. Brong second the motion.

The vote was taken, and on a vote of 7 to 1, with Mrs. Cole voting no, it was

RESOLVED, That the Board table the recommendation and refer the issue back to the Finance Committee for further discussion.

UNFINISHED/NEW BUSINESS

Mr. Currie noted that campaign signs have been going up around the district. He asked about the status of the Act 1 mailing to public.

Dr. Amuso responded that the spring newsletter is going out to residents within the next week. Act 1 information will be on the front page. The Bucks County Board of Elections has notified us that the referendum question has been changed, but we have not heard from Montgomery County Board of Elections.

Mr. Currie was concerned that putting the information in the newsletter may not be read by residents who do not have students in the district.

UNFINISHED/NEW BUSINESS

Dr. Parry indicated that something should be sent out to all voters. The newsletter will not be sufficient; the interpretive statement should be more informative.

Mr. Currie said that the mailing needs to entice the voters to read it. We need to send information out regarding how a no or yes vote will affect the voters.

Mr. Miller added that some people in our area do not read the local papers or check the district's website and they need to be informed.

Dr. Amuso indicated that the district will send out another mailing to all registered voters in the district.

Dr. Baumgartner suggested writing a letter and placing it in the editorial section of the local papers.

On another subject, Mr. Verbeke talked about the American Flag Code and distributed a pamphlet to Board members about the American flag, and how the glad should be included in eighth grade curriculum.

Mr. Gallagher stated that the district had processed an order for the poster version of the pamphlet.

Mr. Verbeke has researched the flag policies in the Souderton Area School District policy manual and would like the policy committee to review these policies and make sure that policies are enforced.

Mr. Verbeke questioned the contingency fund for the new high school project by asking how much is in the fund, and can the money be used for shifting funds to the Capital Reserve Fund. He also questioned if there would be any profit from the sale of the old high school.

Dr. Amuso responded that it is unknown how much money will be left in the contingency fund. It may be possible to use the money remaining in the contingency fund, plus any profit from the sale of the old high school and put those funds into the Capital Reserve Fund.

Mr. Verbeke asked about fundraising efforts for the new high school.

Mrs. Cole provided information from her participation in the Pennsylvania Stakeholders Meeting regarding a Costing-Out Study. She spoke about state board priorities, the overview of the study, methodologies being used to estimate the cost of adequacy, and what successful school districts are doing.

BOARD COMMENTS

No comments.

PUBLIC COMMENTS

Representative Robert Godshall, of Franconia Township, spoke regarding the Accountability Block Grants and how legislators and Governor Rendell are aware of districts that will benefit from the grants. Several legislators have signed a letter to the Governor about their concern for districts who cannot execute the mandates for Accountability Block Grants.

Mr. Sultanik stated that school districts can only decrease professional staff for reasons of reorganization or alteration/removal of programs, not due to increased class sizes. Souderton is considered a district with a growing population.

Representative Godshall also asked about Souderton's efforts to educate the public about Act 1. He shared information on how another local school district was publicizing the information for their residents.

Mr. Rick Mast, from Lower Salford Township, shared a concern about school bus safety. He asked if there were any options to the student for travel if they did not go on the school bus for a field trip. Mr. Mast asked if there was the likelihood for seat belts on the buses in the future or at least have the option of a limited number of buses with seat belts.

Dr. Amuso responded that it is administrative procedure that students who go on field trips are to travel on the bus so they are adequately supervised.

Mr. Gallagher added that field trip Policy #121 states that supervision begins at the school house doors. If the student is not in the approved vehicle, then they are not supervised. Bus drivers are well trained and bus speeds are controlled.

Mr. MacDougall asked the administration to look into Mr. Mast's concerns.

ADJOURNMENT

With no further business, a motion was made by Dr. Parry, second by Mr. Currie to adjourn the meeting. On a vote of 8 to 0 it was

RESOLVED, That the Board adjourn the meeting at 9:19 PM.
