Multiple Occupancy Affidavit

When enrolling a child/children in the Souderton Area School District, it is necessary to established residency.

The attached Multiple Occupancy Affidavit must be completed, signed and notarized by both the legal parent of the child/children being registered and the legal homeowner of the district. This affidavit is used when the parent(s) and child(ren) to be enrolled are residing with a person who owns or rents a property within the Souderton Area School District boundaries.

- 1. Complete "Affidavit of Residence" (this form is to be completed by person attempting to establish residency).
- 2. Complete "Certification of Multiple Occupancy by Owner/Renter" (this form is to be completed by owner/renter of property).
- 3. These forms must be notarized.
- 4. Completing and notarizing both an "Affidavit of Residence" and a "Certification of Multiple Occupancy by Owner/Renter" is required each school year.
- 5. Return all completed forms to Registration Office.
- 6. Acceptable proofs of residency must include the legal parent/guardians name and full physical address of property (PO's are not acceptable forms):

Parent or Guardian:

One of the following: Driver's License or Motor Vehicle • **Registration Card with current address (Change of address** verification printout for both will be accepted), Current Bank Statement or Credit Card Bill.

Owner:

One of the following: Current Utility Bill (Water, Electric or Sewer), Tax Bill, Mortgage Statement or Deed.

Renter:

Current signed lease

As with all students who are attending Souderton Area School District on the strength of an affidavit, whether student support or multiple occupancy, the district will conduct before-school neighborhood observations on a random basis throughout the year to verify compliance to the conditions of the affidavit; and should it be determined that all conditions of the affidavit are not met, I shall then be liable to reimburse the Souderton Area School District at the tuition rate* calculated by the Pennsylvania Department of Education based upon the previous vear's Financial Report for those days of improper attendance in the Souderton Area Schools, in addition to legal fees, court costs and administrative costs. *Tuition is subject to change without notice.

I understand that if the District determines that (a) I have supplied false information to the District and/or (b) the information that | provided ceases to be true and | failed to inform the District of the change in circumstances prior to or at the time the change occurred, then in addition to or in lieu of civil proceedings for collection of nonresident tuition and/or exclusion proceedings, the District may refer the matter to appropriate law enforcement officials and/or initiate a private criminal complaint against you for unsworn falsification to authorities, theft of services and/or any other applicable criminal offenses.
